#### Annual Blanket License

What is "Annual Blanket License"? An annual blanket license provides you with a music library, or in our case, with a bundle/s of music tracks and grants you a "blanket coverage" with the right to unlimited number of synchronizations of musical expressions/themes. In practical terms, an annual blanket license means you can use your library/bundles of music tracks as many times as you desire in an unlimited number of productions, during your annual term, without additional cost.

By having musical expressions in a bundle available to you at any time during your licensing period, you can enjoy more creative flexibility and concentrate on developing your projects.

#### **CustomizedMedia, LLC Annual Blanket License Terms**

When you purchase and download music tracks from CustomizedMedia.net, and select the "Commercial License - Annual Blanket License" option, you ("Licensee") obtain a non-exclusive license for commercial use for 1 (one) year. This is a one-time payment only for the annual license term.

The CustomizedMedia, LLC "Annual Blanket License" includes Synchronization and Master Use licenses for the annual term.  
Note:

Synchronization License: permission by the copyright owner of a musical composition for use in an audio-visual production.  
Master Use License: permission by the copyright owner of a sound recording for use in an audio-visual production.

Any use of the downloaded music tracks by Licensee in a production completed during the license term is covered for the life of that production, royalty free. This relates only to finished productions the body of which is not modified in any way or revised at a later date, past the annual term of the license. Licensee may use any music selection, from the downloaded bundle/s of music tracks, in audio, video, multimedia, and Web projects including: film, TV, commercials, Web and corporate presentations.

Licensee cannot re-sell or re-license, either in whole or in part, the music itself from the CustomizedMedia™ Music Library. CustomizedMedia, LLC retains copyright to the musical compositions and sound recordings. Licensee shall use the music only for its own production needs.

When Licensee uses the downloaded music in productions that are broadcasted on television and radio, including national and international networks, cable, local networks, and in theatrical presentations, Licensee is required to submit a Cue Sheet to ASCAP for the usage of the music.

By making a purchase and downloading music tracks from CustomizedMedia.net, under the "Commercial License - Annual Blanket License" option, you agree that you have read, understand and accept these terms, and to be bound by them.
